

Privacy Policy

This privacy policy applies between you, the User of this website, Tayler London-Williams & Carole London-Williams trading as Lie Detector Investigations. This privacy policy applies to our use of any and all Data collected by us or provided by you in relation to the use of the Website. **Please reads this privacy policy carefully.**

Definitions and Interpretation

1. In this privacy policy, the following definitions are used:

Data	collectively all information that you submit to Tayler London-Williams trading as Lie Detector Investigations & Carole London-Williams trading as Polygraph Services via the Website. This definition incorporates, where applicable, the definitions provided in the Data Protection Act 1998;
Cookies	a small text file placed on your computer by this Website when you visit certain parts of the Website and/or when you use certain features of the Website. Details of the cookies used by this Website are set out in the clause below (Cookies);

2. In this privacy policy, unless the context requires a different interpretation:
 - a. the singular includes the plural and vice versa;
 - b. reference to sub-clauses, schedules or appendices are to sub-clauses, clauses, schedules or appendices of this privacy policy;
 - c. a reference to a person includes firms, companies, government entities, trusts and partnerships;
 - d. "including" is understood to mean "including without limitation";
 - e. reference to any statutory provision includes modification or amendment of it;
 - f. the headings and sub-headings do not form part of this privacy policy.

Scope of this privacy policy

3. Data collected

Our use of Data

6. We will retain any Data you submit via the Website for a period of 1 month.
7. Unless we are obliged or permitted by law to do so, and subject to any third-party disclosures specifically set out in this policy, your Data will not be disclosed to third parties. This includes our affiliates and/or other companies within our group.
8. All personal Data is stored securely in accordance with the principles of the Data Protection Act 1998. For more details on security see the clause below (Security).
9. Any or all of the above Data may be required by us from time to time in order to provide you with the best possible service and experience when using our Website. Specifically, Data may be used by us for the following reasons.
 - a. Internal record keeping;
 - b. Transmission by email of promotional materials that may be of interest to you; In each case, in accordance with this privacy policy.

Third party websites and services

Purpose

Strictly necessary cookies
